TERMS AND CONDITIONS

Please read the following terms and conditions. Your application submission and payment serve as your acceptance.

- Vendors may register and setup at 9:00 am. Must be complete by 10:45 am.
- Upon arrival, Vendors may unload at the curb. Please use the West Entrance (Outer Drive/Lindsey).
- Being mindful of other vendors, please move all vehicles to the West lot following unloading.
- All Vendors will receive one 8" table and 2 chairs unless multiple space purchased.
- Bring your own table linen for each table
- All materials must fit in the space allocated.
- Vendors must sell what they communicated on their vendor application.
- Sales of products including controlled substances are prohibited.
- NO display or product may be hung from the walls you MUST bring your own hanging/display structure.
- Vendors are responsible for their own sales transactions.
- Vendors must bring their own electrical cords (if electricity is purchased)
- Vendors are responsible for their personal items and cleanup of their assigned space.
- Merchandise can be left over night on Saturday, and it will be secured.
- Vendors are not allowed to change/trade assigned locations with other vendors.
- Vendor fees are non-refundable and non-transferable unless application is approved, or event is cancelled by the organizer.
- NO sales allowed during WORSHIP SERVICE on Sunday.

Vendors may register and setup at 8:00 am. Must be complete by 9:15 am. Service begins at 9:30 am. The Bazaar will begin immediately following service.

- NO food may be consumed, or uncovered beverages allowed outside the room where the Bazaar is being held. Tables are available inside for meals.
